## JNET VISION

To be the data integration innovation leader for Pennsylvania's criminal justice and public safety communities.

### **JNET Mission**

To provide highly available, secure, and accurate data and integration services to Pennsylvania's criminal justice and public safety communities.



### JNET

Pennsylvania's premier Public Safety and Criminal Justice information broker. Provides authorized users with timely and secure access to critical criminal justice information from state, federal and local agencies.

JNET users may access statewide court records, warrants, booking photos as well as information from non-traditional Law Enforcement agencies such as PennDOT and the Department of Labor and Industry.

JNET leverages role based advanced authentication to securely broker information from partnering agencies. These agencies are able to control who has access to their information by setting policy and training standards.

#### **JNET PORTAL**

The JNET portal is a secure mobile-friendly website that provides authorized users access to criminal justice data through 28 applications.

- Traffic Stop provides driver and vehicle information combined with information on active warrants and hot file information.
- Criminal Complaint electronically submit criminal complaints with the courts.
- Warrant Search returns warrant results from PA State Police, the National Crime Information Center, PA Courts and domestic relations and child support warrants.
- PennDOT Search includes driver photos, demographics, certified driving records and vehicle registration.
- Unified Judicial System Portal gives JNET users the ability to access important case, court, participant, and warrant information not available to the public.
- WebCPIN provides a tool for the identification of criminal subjects through photo imaging.
- PA Chiefs of Police Facial Recognition is an investigative tool that uses computer technology to analyze and compare individual digital images for identifying potential candidates or witnesses to crimes.
- PSP CLEAN PortalXL provides online access to PSP CLEAN including PA SORT (SEX Offender Registration Tool), National Law Enforcement Telecommunications System (NLETS) and the Interstate Identification Index (III) records.

## **JNET NOTIFICATIONS**

JNET notification services allow agencies and their users to subscribe to customized events to meet their specific business needs. Whether it is a probation officer supervising active parolees or a police detective monitoring outstanding warrants, JNET notification services can be customized to ensure the right information is provided to the right person at the right time allowing users to proactively monitor subjects.

Examples of JNET messaging events include:

- Arrests
- Warrants
- Court case events (case initiation, case bind-over, case disposition)
- M Address changes
- Jail admissions or releases



#### **JNET MESSAGING**

JNET's robust service-oriented architecture supports data exchanges, event services and service interactions between local, state and federal criminal justice agency systems. JNET's flexibility ensures that electronic record exchanges meet the specific business needs of its criminal justice partners using national standards.

JNET services include various electronic court filings, JNET event messages, court case event information, driver and vehicle information, employment information, license pickup lists, license plate reader data, and much more.
